

### Decision/Order of the Commission

#### आयोग का निर्णय /आदेश

Appeal under section 24 of the National Commission for Homoeopathy Act 2020, submitted by Principal, Lokmanya Medical Foundation's Homoeopathic Medical College, vide letter no. LSFPEF'S-LHMC/NCH/282/2024 dated 25.07.2024.

Appeal vide letter no. LSFPEF'S-LHMC/NCH/282/2024 dated 25.07.2024 from Lokmanya Medical Foundation's Homoeopathic Medical College has been received by the Commission under section 24 of NCH Act 2020 against the decision of Medical Assessment and Rating Board for Homoeopathy (MARBH).

The MARBH conducted inspection on 27.06.2024 & 28.06.2024 and followed by this MARBH vide letter no. 4-7/2024-25/NCH(MARBH) (115-03)/3006-3013 dated 04.07.2024 decided to issue denial for renewal of permission for conducting BHMS Course with students' intake of 100 Seats in UG (BHMS) Course for A.Y 2024-25.

The Commission upon examination of the documents submitted by the college with the appeal, has made the following observations:

##### Observation on Teaching Faculty:

- Faculty Qualifications:** Dr. Nandini S. Joshi's appointment as Principal does not meet the MD qualification requirement as per MSR 2013, which is a critical shortfall impacting regulatory compliance. Despite this, she has extensive experience and holds university approvals as a professor and principal, showcasing her longstanding contribution to the institution.
- Faculty Vacancies:** The college made an effort to address the vacant Professor position by advertising the role in December 2023, indicating steps to fill the gap. The position remains unfilled, and there is insufficient justification for the delay or additional steps taken to secure a candidate sooner.
- The submitted documents, including signatures on the muster roll, do not clearly indicate whether the staff members are full-time employees. Additionally, there are discrepancies in the leave reports.

4. It is difficult to establish correlations as signatures could have been added later. Inspectors should have signed the register to validate the data at the time of inspection.
5. The list of Guest Faculty is provided but it does not verify the availability of guest faculties in the college. No documents were provided to verify their presence and academic activity.
6. MOU of transport company submitted though it is after the date of an inspection but can be considered as a step for improvement

### **Overall observation:**

While reviewing the submitted documents and information for the GRC, several significant discrepancies and issues have been noted:

1. **Faculty Appointment:** The Principal does not meet the essential MD qualification requirement as per MSR 2013, and key career progression documents, such as approvals for Lecturer and Reader positions, are missing.
2. **Faculty Recruitment:** The college has taken steps to recruit a Professor for the Department of Practice of Medicine by issuing an advertisement.
3. **Staff Attendance and Leave Reports:** There are discrepancies in the staff attendance and leave reports, with some staff members' full-time status being unclear. This raises concerns about the availability of faculty and continuity of education.
4. **Guest Faculty Documentation:** The submitted list of guest faculty lacks supporting documents verifying their presence and academic activities.
5. **Hospital Facilities - Records Discrepancy:** Discrepancies in the central and departmental registers indicate potential issues with record accuracy, raising doubts about the functional integrity of the hospital's OPD and IPD services.
6. **Infrastructure Maintenance:** The purchase of new reagents by the college has shown initiative including investment in improving diagnostic services, which can be considered as a positive step.
7. **X-ray Facility:** The functionality of the X-ray unit remains questionable due to the lack of a full-time technician and insufficient documentation to verify its operational status.
8. **MOU Submission:** The college submitted an MOU to address clinical and educational requirements, but it was provided after the inspection. While this shows an attempt to rectify deficiencies, it does not address the immediate needs observed during the inspection.
9. **Yoga Unit:** The functionality of the yoga unit could not be established based on the provided photographs and records, raising concerns about the availability of adequate facilities for students.
10. **AEBAS:** The institution has purchased the AEBAS system, demonstrating a commitment to improving staff attendance tracking. However, its full functionality has yet to be substantiated.

The college has demonstrated some efforts like in faculty recruitment and infrastructure improvements but there is still deficiency persisting like staff verification, and in some areas of hospital functionality. These issues impact the quality of education and healthcare delivery. In view of the above, there is partial compliance with the regulatory requirements and there is scope for improvement. Based on the above findings, the Grievance Redressal Committee (GRC) recommends reducing the intake capacity for the BHMS course from 100 to 60 seats for 1st BHMS course for the academic year 2024-25

- II. Accordingly, your representation dated 25.07.2024 to Commission against MARBH letter dated 04.07.2024 stands disposed off
- III. If aggrieved with the above decision as per section 24 (3) of NCH Act 2020 may place a second appeal to the Central Government (Ministry of Ayush) within 30 days of issue of this communication of above decision.
