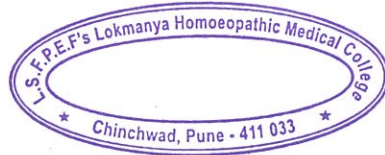

Sir,

Lokmanya Medical Foundation's Homoeopathic Medical College has applied for permission for sanction of BHMS course with 100 seats for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH conducted Inspection on 20.05.2025 & 21.05.2025. The Medical Assessment and Rating Board has examined the College as to whether the college fulfils the Minimum Essential Standards as per the prevailing regulations under clauses 26 and 28 of the NCH Act 2020. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls: -

1. Teaching faculty.

- Associate professor in the department of anatomy.
- Associate professor in the department of practice of medicine.
- Professor in the department of surgery.
- The principal is holding the post of reader in the department of community medicine. As per MES 2024 Principal should be a separate post.

As evident from the above statement, a total number of four teachers are deficient against the requirement of 40+1 for 100 seats UG college (As specified in MES,2024). Pursuant to F.No.: 3- 2/MARBH/NCH/2025-26/162-169 dated 16/04/2025 issued by MARBH, a college can avail of 10% relaxation in college up to 100 seats against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 10%, college has no deficiency of teachers. Although, such a relaxed number of teachers should also be appointed at the earliest for smooth conduct of course.

2. Miscellaneous

- NABL accreditation for clinical laboratory not done
- NABH accreditation for hospital not done.
- The salary of teaching staff and non-teaching staff is not as per MES 2024.

3. Considering the above observations during inspection MARBH has decided to issue Conditional Permission to Lokmanya Medical Foundation's Homoeopathic Medical College, Near Elpro Company, Behind Auditorium of P.C.M. Chinchwad, Pune-411033 for continuing BHMS Course with intake capacity of 100 seats for the academic year 2025-26 on the basis of following condition -



- a) The salary of the staff should be as per the criteria mentioned in MES 2024.
  - b) NABL accreditation for clinical laboratory at the earliest.
  - c) NABH accreditation for hospital at the earliest.
4. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of 100 UG seats shall be treated as All India Quota. Counseling for seats under all India quotas shall be conducted by respective Counseling Authority of State/UT govt as designated by Central Government and counseling for the remaining 85% seats or as the case may be shall be conducted by the concerned counseling authority of the state/UT.
  5. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
  6. Conditions under point 3 should be fulfilled within a period of one month and the compliance report shall be submitted for verification to the office, failing which permission for the academic year 2025-26 may be withdrawn.

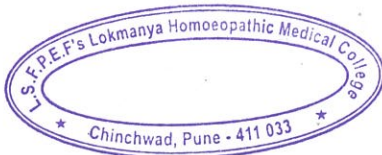

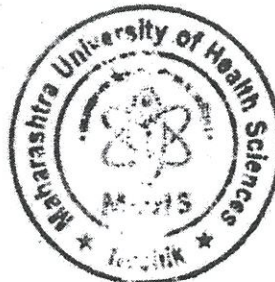
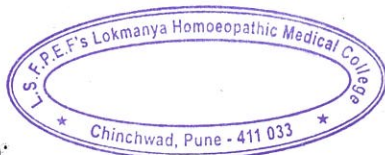
- a. The College shall submit Affidavit in the prescribed format as per Academic Council's Resolution No. 229/2013 (format attached).

(vii) **Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 03 (three) months, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.**

**Important Note:**

- 1) This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of National Commission for Homoeopathy / Government of India/Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1<sup>st</sup> Year of the course until receipt of permission of the National Commission for Homoeopathy / Government of India /Department of AYUSH, New Delhi.
- 2) This Conditional Continuation of affiliation is issued subject to the condition that the college can be transferred in its own building within the period as directed by the University and there shall not be adverse effect on the academics of the students prosecuting the studies due to the alleged land / building dispute. The college shall be solely responsible in case of breach of this condition.
- 3) The admission shall be done through the Competent Authorities only.
