Chinchwad, Pune-411033, Maharashtra for Admission in BHMS Course with intake capacity of 100 seats for the academic year 2026-27- reg.

Sir/Madam,

Lokmanya Medical Foundation's Homoeopathic Medical College has submitted an application for 100 seats in BHMS course for the academic year 2026-27. The Medical Assessment and Rating Board (MARBH) has conducted inspection of college on 12.05.2026 and 13.05.2026 followed by hearing on 09.06.2026. MARBH has examined the College to ascertain whether the college fulfils the Minimum Essential Standards as per the regulations in force. On careful examination of the report, the Medical Assessment and Rating Board observed the following shortfalls:

A. College Functioning:

- a) Teaching faculty - Associate professor (01) in the department of Surgery vacant.

B. Salary: Salary of teaching non-teaching and hospital staff is not as per MES 2024.

2. Considering the observations during examination of inspection report and hearing, MARBH has decided to issue **Conditional Permission to Lokmanya Medical Foundation's Homoeopathic Medical College, Near Elpro Company, Behind Auditorium of P.C.M. Chinchwad, Pune-411033, Maharashtra for Admission in BHMS course with intake capacity of 100 seats for the academic year 2026-27 on basis of following conditions:**

- i. Teaching faculty (01) shall be appointed and registered on AEBAS as per First Schedule of National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024 within 30 days.
- ii. Salary of staff should be as per First Schedule of National Commission for Homoeopathy (Minimum Essential Standards for Homoeopathic Colleges and Attached Hospitals) Regulations, 2024.

Deficiencies mentioned above should be rectified within a period of 30 days and the compliance report must be submitted to the undersigned, failing which conditional permission issued will be withdrawn without further notice

3. All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of undergraduate seats of the permitted intake capacity of UG seats shall be treated as All India Quota. Counselling for seats under all India quota shall be conducted by respective Counselling Authority of State/UT Government as designated by Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counselling authority of the state/UT Government.

4. The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.
